PRESIDENT'S REPORT

Things have been very busy the last couple of weeks. We continue to bargain with the Company with the goal to bring the membership a contract that the Negotiating committee can recommend for ratification.

April 29 was the National Day of Mourning when we remember and mourn workers who have been killed on the job, died of occupational diseases or suffered life altering injuries.

May 1st was May Day, International Workers Day. Despite the weather Local 1005 had a good turn out.

May 5th Stelco released the 2022 Q1 results. Stelco had a record Q1 EBITDA of \$402m, continue to pay a dividend of \$0.30/share and returned \$215m to shareholders.

On May 6th, the Company told us that the PSP bonus would be approx. \$1800/member and the PBI bonus would be approx. \$200/member. Timing is everything.

May 9th is the 30th Anniversary of the Westray mining disaster, when 26 miners were killed due the criminal negligence of the employer. Local 1005's H&S Primary Co-Chair Brandon Cross will be there to represent our Local.

Your grievance committee has been busy dealing with all the issues that have come forward. We are now in the process of Collective Bargaining for the renewal of a new Collective Agreement that expires on June 30th, 2022. The bargaining protocol agreement that we as a union entered is that we will continue to process all grievances; at this time, there is a moratorium on third step grievances and arbitration except for terminations or grievances alleging harassment, discrimination and/or duty to accommodate or human rights violations. If you believe you have a grievance, please reach out to your chief steward or call the Union Hall at 905-547-1417, and we will continue to advance them and protect the time limits, so once we have a new collective agreement, we will move them to the next stage of the grievance procedure.

We continue to deal with Covid-related issues in the plant. Our members have continued to work every day over the last few years and continued to produce the wealth so the company could continue to make record profits. Our workplace never implemented a mandatory vaccine policy or a mandatory testing requirement; if they did choose to do so, we as a Union would have filed a policy Grievance alleging that the policy is unreasonable. We have always taken the position that "we fight for the rights of all" I encourage you to continue to support your bargaining committee.



THE LATEST ON HEALTH & SAFETY



FRANK MESICH April 28th is "the Day of Mourning "which is always one of the most important events on labours calendar. It's an important day for us to remember and mourn the loss of coworkers who have been injured or killed on the job or have died from occupational diseases. This year is especially significant for us at Local 1005 as we remember Brother Kirk Moore who was killed on the job at Stelco on January 15, 2022. Recently we passed a motion to rename our local 1005 golf tournament after Brother Moore, but the best way to remember him is to ensure another workplace tragedy never occurs

Brother Moore was 66 years of age and had worked at stelco for 43 years. He leaves behind his 2 sons, Christian and Paul. Kirk was popular with his co-workers and respected by his supervisors. He was looking forward to retiring and spending more time with his sons, golfing and travelling with

Friends. Sadly, that won't happen.

We pledge that "we mourn the dead and fight for the living", but the reality is that we continue to fight for the dead as well.

Companies and employers try to avoid responsibility and blame the victims, so they won't be fined or charged. Its despicable that companies blame workers who have been killed since they aren't able to defend themselves.

The 30th anniversary of the Westray mining disaster is on May 9th. On that day 26 miners died because of the willful negligence of the employer. The Steelworkers were instrumental in getting the Westray Law enacted, which paved the way for criminal prosecution of employers in the death of workers.

It's not a radical idea, that when you go to work you return home safely.

Because of the many processes involved in the making of Steel and Steel products, Stelco workers have a high risk of dying from the results of an industrial accident or industrial occupational disease.

We can all relate to the loss of a fellow worker at the time of death, but very few of us realize that everyone of us working in the plant are subject to CARCINOGENS (cancer causing agents) and potential DEATH TRAPS each working day. Part of the inability to recognize these potential hazards is due to the false security that we develop over the years of doing the same job.

There have been fatalities in all areas of the plant over the years starting with data we have dating back to July 1940 and the most recent one of Kirk Moore in January 2022, but the ones few of us ever hear about are those fatalities caused by cancer.

Question all unknown chemicals and processes in your work areas. Ask to see the safety data sheet (SDS) concerning any chemical in the workplace.

In cases of terminal illness or accidental industrial death have the family contact your Union compensation and Health & Safety committees.

Anyone knowing of a co-worker who has cancer and feels it is work related, please notify Tony McLaughlin or Jim McColl at the Union Hall. This is most important when initiating a cancer claim.

You could help in getting a survivorship claim allowed for a grieving family who does not need HARDSHIP ON TOP OF HEARTACHE.

Stop the killing. Enforce the law.
